

SOMOS MAVS EL REGALO SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS INTENDED FOR VIEWING IN TEXAS ONLY AND WILL BE GOVERNED BY UNITED STATES LAW. VOID OUTSIDE OF TX AND WHERE PROHIBITED.

1. ELIGIBILITY:

The “Somos Mavs El Regalo Sweepstakes” (“Sweepstakes”) is open to legal residents within Texas who reside within a 150-mile radius of Dallas, Texas, excluding 75-mile radius of Oklahoma City and are twenty-one (21) years of age or older at the time of entry (the “Entrant”). Employees, contractors, directors, officers and agents of Anheuser-Busch, LLC, its affiliates and subsidiaries, divisions, advertising and promotion agencies, suppliers, wholesale distributors or retail licensees of alcohol beverage products, and any other alcoholic beverage industry members, other service or governmental agencies and their employees involved with the Sweepstakes, the NBA Properties, Inc. the National Basketball Association (the “NBA”), and the NBA member teams (collectively, the “NBA Entities”), and members of their immediate family (spouse, parent, child, or sibling) or persons living in the same household are not eligible to enter or win. 2. SWEEPSTAKES PERIOD:

Sweepstakes begins at 12:00:00 a.m. Central Daylight Time (“CT”) on February 26, 2024, and ends at 11:59:59 p.m. CT on April 30, 2024 (“Sweepstakes Period”), subject to drawing dates as outlined in section 4 “SWEEPSTAKES DRAWINGS”. The Website (defined below) computer is the official time keeping device for this Sweepstakes.

3. HOW TO ENTER: Entrants must submit an entry by 11:59:59 p.m. CT the day before the drawing date outlined in section “SWEEPSTAKES DRAWINGS”. Nonwinning eligible entries will be eligible for the next available drawing.

(a) Online: Visit <https://airbaton.net/f0gHzHEFQweZ8nEF2C6A?hc=2sQ1&city=Dallas> (“Website”) during the Sweepstakes Period and follow the online instructions to complete and submit an online entry (“Entry”). The online entry form must be completed in its entirety, all required fields, to receive one (1) Entry into the Sweepstakes.

(b) QR Code: Use your smart phone or other web-enabled device with data plan to scan the Sweepstakes quick response (“QR”) code featured on signs or promotional materials at participating stores with the QR read application already installed on your phone. You will be directed to a mobile Web page at <https://airbaton.net/f0gHzHEFQweZ8nEF2C6A?hc=2sQ1&city=Dallas> (also a “Website”) where you may complete and submit an entry (also an “Entry”). The entry form must be completed in its entirety, all required fields, to receive one (1) Entry into the Sweepstakes.

- (a) Instagram: In order to enter via Instagram®, you must be a registered Instagram user and your profile settings must be set to “public”. To become a registered user of Instagram, create an account on Instagram at www.instagram.com. Proof of scanning QR codes does not constitute proof of completion or submission of an entry. Sponsor will not verify receipt of entries for Entrants.

All Entries must be received and recorded by the date and time outlined in the Entry Period section in order to be eligible for that respective Entry Period drawing. No other forms of Entry are valid. Limit one (1) Entry per person per Entry Period.

4. SWEEPSTAKES DRAWING:

Potential prize winner(s) will be selected in a random drawing to be held on or about the following dates: February 29, 2024 (One (1) Los Mavs VIP Experience prize winner), March 15,

2024 (Three (3) First Prize Swag prize winners), March 31, 2024 (One (1) Sneakeasy VIP Experience prize winner), and April 16, 2024 (One (1) Grand prize winner), May 2, 2024 (Three (3) First Prize Swag prize winners). Potential prize winner(s) will be selected from among all eligible Entries received during the Sweepstakes Period. Sponsor's decisions are final in all matters relating to this Sweepstakes. Odds of winning depend on the number of eligible Entries received during the entry period leading up to 11:59pm CT the day before the drawing date.

5. PRIZE WINNER NOTIFICATION:

All prizes will be awarded (time permitting). Potential prize winner will be notified via email or via direct message via Instagram and will be required to respond to the notification within twenty-four (24) hours indicating whether they can accept the prize. If a potential prize winner does not respond to the notification within the twenty-four (24) hour time period, prize will be forfeited, and an alternate potential winner will be randomly selected (time permitting). Any alternate potential prize winner selected will also be required to respond to the notification within the time frame stated above.

Potential prize winner will be required to complete, sign, and return an affidavit of eligibility and liability and, unless prohibited by law, publicity release to Sponsor or Sponsor's representative within twenty-four (24) hours of prize acceptance. Transportation, accommodations, meals, gratuities, and all other expenses not specified herein are prize winner's responsibility. Prize winner will need to adhere to the requirements of the Venue hosting the Game.
